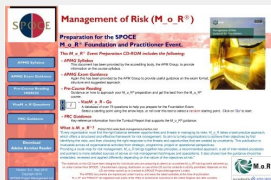
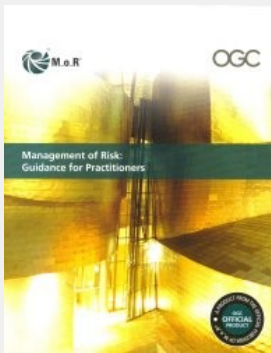

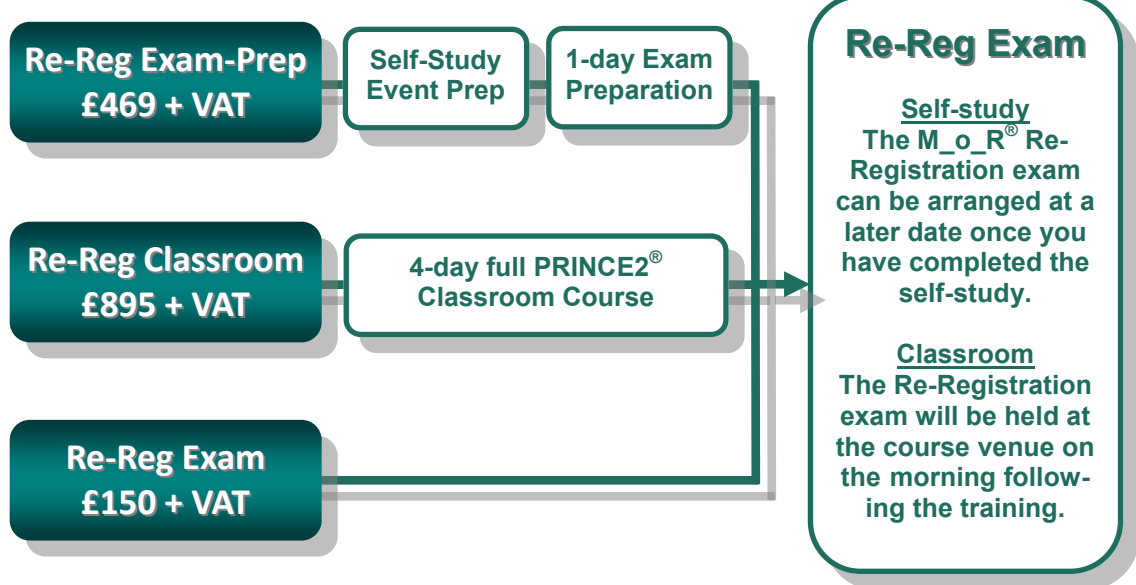

## What is the format of the Re-Registration Exam?

The M\_o\_R® Re-registration Exam is an objective test based exam, taking the same format as the Practitioner. The 1-hour, 20 minute exam comprises four questions each worth 20 marks. Candidates must score a total of 40 marks from a possible 80 to pass the exam.

The exam is "Open Book". Candidates may make use of the Management of Risk: Guidance for Practitioners (the M\_o\_R® 'Manual'), together with the APMG guidance document 'ABC Consulting Ltd'; Sample Risk Documents and Worked Examples of some of the Common Techniques (all supplied by SPOCE). No other material can be used during the exam.

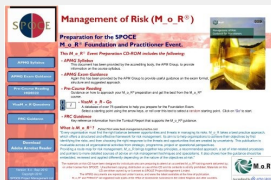
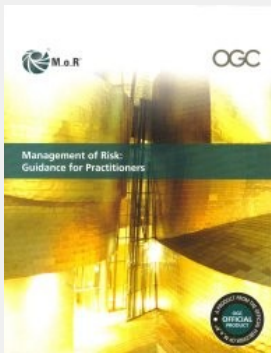

## Re-Reg Classroom - £895 + P&P + VAT

This is the full 4-day training course which will prepare you thoroughly for the Re-Registration Exam. The M\_o\_R® Guidance was released in 2002 and updated in 2007 and 2011. SPOCE recommends that individuals who have not studied the M\_o\_R® Guide for a while should choose the classroom option. This includes the latest M\_o\_R® Manual; exam preparation CD; 4-days training; all course handouts; lunch & refreshments and the Re-Registration Exam.

## Re-Reg Exam Prep - £469 + P&P + VAT

This exam preparation event is designed for practitioners who have kept up to date of the changes in the M\_o\_R® Guidance. The event will review the M\_o\_R® guidance and use sample exam papers to prepare for the Re-Registration Exam. Includes the latest M\_o\_R® Manual; event preparation CD-ROM; 1-day M\_o\_R® Exam Preparation Event; and the M\_o\_R® Re-Registration Exam. The exam can be taken either at any SPOCE exam venue.

## Re-Registration Exam only - £150 + VAT

This is just the M\_o\_R® Re-Registration exam without any training provided by SPOCE. The exam can be taken either at any SPOCE exam venue. Please note that due to its release in December 2010, SPOCE recommends that the latest version of the M\_o\_R Manual is purchased. This is available at £45.

## Why do I have to re-register?

Re-registration for M\_o\_R® has been available since the beginning of 2008. All M\_o\_R® Practitioners should be re-registered within 3-5 years of their original certification. Those who have taken the examination have agreed to this requirement as part of their initial application and so are now designated as Registered Practitioners.

All Practitioners certified have the opportunity to take the Re-registration examination in order to demonstrate their commitment to professional development. This is particularly important following the recent update to the M\_o\_R Guide. By taking the Re-registration examinations, candidates are able to demonstrate to employers and prospective employers the recency of their knowledge and commitment to Continuing Professional Development.

## How long does my registration last for?

The registration has a validity of five years and Registered Practitioners will be required to take a re-registration examination to confirm their competence in the M\_o\_R® Methodology before the end of the five year period.

## What happens if I have gone past my 5-year period?

SPOCE can arrange the Re-Registration exam for you. If you have exceeded the 5-year term, you can still take the Re-Registration exam. In the meantime you should be aware that your "Registered" status is lapsed, and this will be shown on the APMG Candidate Register.
